The motion was seconded by Ed Belding and unanimously approved.
- Discuss and Take Necessary Action on ESD Financial Accounting Policy Treasurer, Gale Binder, presented a draft of ESD 7 financial policies for review. Commissioners and VFD members discussed the draft, but no formal action was taken.
- Discuss and Take Necessary Action on FY2018 Strategic Follow Up Items This item was not discussed.
- 7. Discuss and Take Necessary Action on Increased Funding District Chief, Jeff Edwards, discussed options for increased revenue for FY2019 and beyond. No formal action taken.
